

## Unknowns: Why is DMHA Really Doing This?

- This is NOT about cost savings.
- This is NOT about those federal rules.
- This is NOT about closing centers
- This IS about program integrity.
- This IS about aligning funding with practice expectations.
- This IS about larger system change.



#### Unknown: Details on MRO PA

- Primary focus is to allow access to MRO services for "outliers" when medically necessary.
- Current plan is for PA to be done by the state, i.e., not an MCO or BHMCO.
- DMHA will work closely with OMPP to define criteria and minimize administrative burden.



#### Unknowns: 1915i

- Is mechanism to continue needed serves to those you may currently be serving with MRO, but whose needs are habilitative in nature.
- Defining population and service needs is underway.
- OMPP and DMHA will be collaborating with you to finalize the program parameters.



#### Unknowns: 1915i

- 1915i Option is on track for implementation by July 1, 2010.
- Accessing option slots is scheduled to begin prior to July 1, 2010.
- Screening for slots must be done by independent entity.
