



Dedicated to improving the well-being of individuals and families, Centerstone offers a wide range of services, including counseling, therapy, addiction recovery programs, psychiatric care, and crisis intervention. With a client-centered approach, their team of professionals focuses on delivering compassionate, evidence-based care to address

mental health challenges and promote long-term recovery. Centerstone also provides support for individuals managing chronic conditions, ensuring accessible and affordable healthcare for all in the Bloomington community.

Centerstone is excited to share about recent expansions in several of our service areas.

Our Centerstone SUD residential treatment programs continue to expand with nine facilities, including our new recovery housing facilities in Bartholomew and Wayne Counties.

The continuum includes ASAM 3.1 and 3.5 programming. **Centerstone Recovery Centers** (CRC) provide up to 28 days of residential treatment, depending on medical necessity. We serve individuals requiring intensive treatment for addiction, including many who qualify as high-risk individuals (homeless, co-occurring diagnoses, hepatitis positive, HIV positive, pregnant, etc.)

In addition, we have transitional housing options for those who complete CRC treatment. As part of our Medication Assisted Treatment (MAT) program, we work with clients who have been prescribed methadone by an Opioid Treatment Provider (OTP), and are in good standing with their OTP. Individuals can continue their Methadone treatment at our CRCs, while addressing recovery needs with other substances.

In October, Centerstone also received a four-year \$3 Million HRSA Rural Communities Opioid Response Program (RCORP) grant serving Brown, Jackson, Jefferson, Jennings, Lawrence and Owen Counties.

The grant will improve access to integrated, coordinated treatment and recovery services for substance use disorder, including opioid use disorder, in rural areas. The initiative enhances coordination with supportive social services and expands recovery housing, to ensure rural individuals and their families impacted by substance use disorder have the greatest opportunity for sustained, long-term recovery.

The grant also builds on Centerstone's current work with Nalox-box distribution and expands access in rural areas.

Another area of development is with our growing crisis service continuum. Centerstone is expanding our **Stride Crisis Stabilization and Receiving Centers**, currently serving Bartholomew, Brown, Decatur, Jackson, Jennings, Jefferson, Lawrence, Monroe, Morgan and Owen Counties. A new Richmond Stride Center is slated to open in January 2025, as our third location, to serve Wayne, Fayette, Rush, Randolph, and Union counties.

Centerstone's Stride Centers provide a safe place for people experiencing a mental health or substance use crisis. Connecting people to local care and recovery resources, Stride Center services can be accessed directly by people in need, first responders, law enforcement, hospitals, social workers and concerned community members. Stride Centers provide diversion for individuals 24/7 and work closely with Centerstone's Rapid Response Treatment Team and Mobile Crisis Response Teams.

#### TITLE 440 DIVISION OF MENTAL HEALTH AND ADDICTION

#### Notice of Public Hearing LSA Document #24-429

Under IC 4-22-2-23, notice is hereby given that on December 16, 2024, at 9:00 a.m., at the Indiana Government Center South, 402 West Washington Street, Conference Room 3 – Wabash Hall, Indianapolis, Indiana, the Division of Mental Health and Addiction (division) will hold a public hearing on adding rules at 440 IAC 12 concerning mental health referral programs established under IC 33-23-18. The division seeks comment on the affected citations listed and any other provisions of Title 440 that may be affected by this rulemaking.

The purpose of this hearing is to receive comments from the public prior to consideration of adoption of these rules by the division. All interested persons are invited and will be given reasonable opportunity to express their views concerning the proposed amendments.

If the division does not receive substantive comments during the public comment period or public hearing, the rule may be adopted with text that is the same as or does not substantially differ from the proposed rule.

The public may attend the division's meeting in person or join remotely by Zoom.

Copies of these rules are now on file at the Division of Mental Health and Addiction, 402 West Washington Street, Room W451, Indianapolis, Indiana and are open for public inspection and copying.

#### Indiana Designated Mobile Crisis Team - Billing FAQ November 1, 2024

- 1. Once enrolled, can Mobile Crisis Teams (MCT) back bill? Until when? Once enroiled, can Mobile Crisis Teams (MCT) back bill? Until when?
  Mobile Crisis Teams can bill back to the date of designation. If enrollment is taking a while,
  Providers may request a waiver of timely filing from the Office of Medicaid Policy and Planning
- 2. What is the correct Place of Service (POS) code to use? Can providers bill for audio-only of telenealth mobile Crisis services:

  The Mobile Crisis Response billing codes (S9484, S9484 UB, S9485, S9485 UB) only apply to in-

- 3. If an MCT responds to the same person multiple times within 24 hours, is that considered multiple separate mobile crisis events or one bundle for one day? multiple separate mobile crisis events or one bundle for one day?

- 4. If there are multiple mobile crisis events in 24 hours, how does follow-up work? It there are multiple mobile criss events in 24 hours, now does tollow-up work?

  If a Mobile Crisis Team responds to the same person multiple times in one day, the team is not required to follow up for both events. The Mobile Crisis Team should provide follow-up services for one event within 14 days and document everything clearly.
- 5. If an MCT brings an individual to the emergency room, how is that event billed? When does the event stop? Does it start back up if the MCT comes back to the ER? the event stop? Does it start back up if the MCT comes back to the EK?

  The Mobile Crisis event stops when dropping off the individual at the emergency room. If the The Mobile Crisis event stops when dropping off the individual at the emergency room. If the Mobile Crisis Team returns after emergency room discharge and the individual is in crisis, then another mobile crisis event begins at that point. If MCT follows up after ED discharge and the individual is not in crisis, this is considered part of the initial Mobile Crisis event.
- 6. If an MCT brings an individual back to the organization's crisis center, how is this event billed? If an MCT brings an individual back to the organization's crisis center, how is this event billed?

  The Mobile Crisis event stops when dropping off the individual at the crisis center. If the Mobile
  Crisis Team transports the individual to a different location after receiving services at the crisis
  center and the individual is no longer in crisis, this is considered part of the initial Mobile Crisis
  event.

## HHS Launches Health Workforce Website and Releases Workforce Report

The Department of Health and Human Services (HHS) has launched a **Join the Health Workforce website**, which highlights support available through HHS for those who are interested in joining or the health workforce or advancing within it. HHS also released a new report, "Health Care Workforce: **Key Issues, Challenges and the Path Forward**."

This report describes some of the challenges facing the health workforce, including undersupply, uneven distribution and administrative burden, as well as how the COVID-19 pandemic exacerbated some of these challenges. The report also summarizes information about the supply and distribution of several major components of the health care workforce, including behavioral health workers, physicians and direct care workers.

#### CY2025 Physician Fee Schedule (PFS) and Hospital Outpatient Prospective Payment System (OPPS)

**Final Rules** have each been issued and will come into effect on January 1, 2025. Thank you so much for all your work in providing feedback and submitting comments this summer.

In light of planned National Council member communications regarding election updates this week, we will provide an initial update on PFS and OPPS final rules in Capitol Connector this Friday and we will provide all members with a longer, detailed memo next week summarizing key finalized provisions.

In the meantime, regarding the PFS Final Rule, the following links to CMS' press release, fact sheet, and final rule page in the Federal Register. Some highlights concerning policy changes from the final rule include: extension of some telehealth flexibilities permitted under CMS' authority absent Congressional action, updated payment for social determinants of health risk assessments as a part of Opioid Use Disorder (OUD) intake activities furnished at Opioid Treatment Programs (OTPs), establishment of a



new add-on code to account for coordinated care, referral services, and peer supports at OTPs, payment for safety planning intervention and post-discharge follow-up, establishment of six G codes that mirror current interprofessional consultation CPT codes used by practitioners who are eligible to bill E/M visits, and recognition of responses to CMS' request for information on Certified Community Behavioral Health Clinics

For the OPPS Final Rule, the following links to CMS' press release, fact sheet, and final rule page in the Federal Register. Some highlights from this final rule include: maintenance of the PHP and IOP rate structures, narrowing the definition of "custody" in Medicare's payment exclusion rule to mitigate barriers to Medicare access by individuals who have recently been released from incarceration or are on parole, probation, or home detention, and changes to Medicaid regulation allowing states implementing the Medicaid clinic services benefit to cover clinic services outside the "four walls" of behavioral health clinics.

#### SAMHSA Unveils Homelessness Awareness Month Toolkit

November is both **National Homelessness Awareness Month** and **National Homeless Youth Awareness Month**.

The Substance Abuse and Mental Health Services Administration (SAMHSA) collaborates with national experts and federal, state and local partners to provide training on housing, treatment and recovery models. These efforts focus on supporting adults, children, and families experiencing or at risk of homelessness and facing serious mental illness, serious emotional disturbances, or substance use challenges.

To highlight and uplift these efforts, SAMHSA has developed a Homelessness Awareness Month Toolkit, complementing the existing Homeless and Housing Resource Center and agency repository of Homeless Programs and Resources.

# HRSA- 25-067 Graduate Psychology Education Program (GPE)

The purpose of the Graduate Psychology Education Program is to train doctoral health service psychology students, interns, and postdoctoral residents in integrated, interdisciplinary behavioral health.

The program will prepare trainees to provide behavioral health services, including trauma informed care and substance use disorder prevention and treatment, in community-based primary care settings in high need and high demand areas. Developing health service psychology faculty is also a key aspect of this program.

**Eligibility:** You can apply if you are an accredited doctoral, internship, and/or post-doctoral residency program of health service psychology (including clinical psychology, counseling, and school psychology). Your training program must be accredited by a nationally recognized accrediting agency, approved for such purposes by the U.S. Department of Education.

#### Behavioral Heath Workforce Education and Training Program for Professionals

The purpose of the Behavioral Health Workforce Education and Training (BHWET) Program for Professionals is to increase the supply of behavioral health professionals and improve the distribution of a well-trained behavioral health workforce. The program has a specific focus on understanding the needs of children, adolescents, and young adults at risk for mental health, trauma, and behavioral health disorders.

The BHWET Program for Professionals prepares the workforce by emphasizing interprofessional team-based models of care, integrating behavioral health training in primary care settings and recruiting a diverse workforce interested in serving high need and high demand areas. The program also invests increasing the number and training of clinical supervisors

#### **Program Requirements:**

- Provide stipend support to students who are in their final experiential training (internship or field placement) prior to graduation for no less than six consecutive months and no more than 12 consecutive months (or 24 months for part-time students).
- Enhance didactic and experiential training
  activities that develop trainee competencies in
  behavioral health and its integration into primary
  care, school settings, and other sub-specialty
  care for the development and implementation
  of interprofessional training (two or more health
  disciplines).
- Create or enhance current evidence-based interprofessional training programs for faculty and field site supervisors supporting BHWET Pro trainees.
- Incorporate technology integration by providing options for distance learning, didactic and experiential training activities, and tele-behavioral health services, and by increasing digital health literacy.
- Establish relationships with community-based partners to assist students with job placement after graduation.

#### **Eligible Applicants**

Accredited institutions of higher education with field placement programs in mental health; accredited doctoral, internship, and post-doctoral residency programs in health service psychology; accredited master and doctoral degree programs in social work.

- \* FQHCs, RHCs, and Hospitals can apply in consortium with one of the above.
- \* Your training program must be either:
- Accredited by a nationally recognized accrediting agency, as specified by the U.S. Department of Education, or
- Approved by a state or tribal government to provide a behavioral health-related training program
- \* Academic-clinical partnerships and consortia are also eligible to apply. All entities applying for an award, including consortia members, must be independently eligible for this program.

## Boston University to Provide Behavioral Health in Aging Certificate to CMHC Staff



As Indiana Council has mentioned in recent meetings and conferences, we've received a grant from Humana to provide training to CMHC employees to assist in working with our aging population in Indiana.

We are proud to announce today that we have partnered with the **Center for Aging & Disability Education and Research (CADER**) at Boston University (BU) to provide a **Behavioral Health in Aging Certificate** to front line staff, OBHPs, and any other staff that a center may want to complete the certificate.

Per BU, "This five-course certificate program will deepen health and human services workers' understanding of the major mental health conditions and substance use concerns facing older adults as well as the importance of promoting mental wellness, and resilience. Attention will be paid to the importance of screening, assessment, and evidence-based interventions."

The courses for this certificate are **FREE** to CMHCs and will provide 22 CE hours. Again, there are no costs to CMHCs for this program. The goal for the Indiana Council is to have a minimum of 350 of our CMHC staff members earn this credential through December 31, 2027, with at least 5 from each center completing the program, though there is ample funding to provide the certificate to more than 5 per center.

#### **Program Overview**

- Typically, if a learner dedicates 2-3 hours/week to the coursework they will complete in 6-9 months
- All coursework is online and self-paced, with one year provided to complete the courses
- Initial cohort will start coursework in January 2025, with others able to enroll and start on a rolling basis after the initial cohort begins

Indiana Council will host an informational Zoom meeting on November 21st with CEOs and center HR staff to provide more details regarding the timeline, enrollment process, and other information. I will send an invite for that meeting soon. Additionally, Indiana Council will host a meeting with our BU partners on December 16th, with program enrollment and orientation starting soon after. Please start considering what staff/roles you would like to participate in this certificate program, as we feel it is a great opportunity to earn this free professional development certificate and learn essential skills for working with our aging population in Indiana.
